OLD BUSINESS

NEW BUSINESS

Management Fee Contract Renewal: Gil submitted the 2024 contract to the Board via email this afternoon. Changes include an increase in hourly fees, the per-door increase approved in the 2024 Budget and a cap on meetings of 2 hours each. The contract will be sent to Jen via DocuSign.

Enumeration of Officers: A motion was made and seconded to remove Lacy as VP; with 4 Directors in agreement, the motion passed. A subsequent motion was made to appoint Matt to the VP position with 4 Directors in agreement, the motion passed.
